

CALL TO THE NOVEMBER, 2022 JACKSON REPUBLICAN COUNTY CONVENTION

The Chairman of the Jackson County Republican Committee, in accordance with Michigan statutes and Michigan Republican Party rules, directs the Republican precinct delegates of Jackson County, Michigan to assemble at the Commonwealth Commerce Center, 209 E. Washington, in the City of Jackson, Michigan on **Thursday, November 10, 2022 at 7 pm** local time for the following purposes:

(1) To elect members of the Jackson Republican Executive Committee for a term commencing at the November, 2022 Jackson Republican County Convention and ending at the November, 2024 Jackson Republican County Convention. The numbers of persons to be elected shall be equal to the number of ex-officio members of the Jackson Republican Executive Committee who are the current Republican Party nominees for certain offices as specified in Michigan Compiled Laws (MCL) section 168.599(1).

(2) The transaction of such business as may properly come before the County Convention as submitted by the Jackson County Republican Chairman or Secretary, or to the Convention Chairman for Organization.

Only those precinct delegates elected in the August, 2022 primary election or appointed by a county convention since that time, and at-large delegates who are current Republican nominees to offices as defined by MCL 168.599(5), will be eligible to vote in the County Convention. The County Convention may, at its discretion, choose to fill any precinct delegate vacancies under the authority of MCL 168.624(d), but only after the election of Executive Committee members pursuant to purpose (1) above. Precinct delegate vacancies shall be filled only in accordance with statute by registered voters from their respective precincts for the remainder of the delegate term. "Temporary" delegates may not be appointed by the convention. Executive Committee candidates should campaign before the convention is called to order. Citizens who want to be elected to the Executive Committee but cannot attend the County Convention must notify the Chairman or the Secretary of the Jackson Republican Party of their candidacy in writing to be considered by the Convention.

The convention will be called to order at 7 pm. Executive Committee and officer candidates should campaign before that time.
